A Message from your President



In 2011 we continued to see the trends of the previous two years with a depressed economy and its accompanying challenges. Orphans come in with little vetting and with health issues that have gone untreated for some time. We continue to see increases in senior Danes surrenders when owners no longer have the time or resources to care for them. We are not seeing great improve-

ment in numbers of applicants, so Danes are in our care for longer timeframes as they wait for the right adopters to come along. The Board of Directors has worked hard to watch our bottom line, reinforcing policies to manage our expenses against our available funds. We also have established and maintained relationships with other rescues in the interest of helping all Danes, not just those that come to MAGDRL. This ensures that someone will help the Danes that need rescuing since no single organization can help them all. Thanks to our Chapter Coordinators for nurturing these relationships because when we all work together, we expand our collective ability to help many more Danes.

Despite these challenges, MAGDRL did well in 2011. We met our ex-

penses and provided necessary care for the Danes that came into our rescue. This is only possible because of the tireless efforts of our volunteers, and the dedication and commitment of our members and patrons to our orphans in need. I am truly amazed at the achievements of our event coordinators and fundraising team leaders and teams. And although many charity's executives earn large



salaries, everyone in MAGDRL is an unpaid volunteer. Every effort we make is solely for the love of the breed, and all donations are used for the support of the orphans in our care.

We are very fortunate to have so many talented and hardworking leaders in this organization. It is truly a labor of love. I cannot say enough what a privilege and honor it is to serve as your president and work with such a wonderful group of people who share my passion for this breed that we all love. Imagine a country without traffic lights, food safety standards, tornado warnings, or a Federal Deposit Insurance Corporation (FDIC) to protect that nest-egg you worked so hard to build. If these and other protections did not exist in our society, our communities would fall into decline and we would quickly become an impoverished, 3rd world country.

In the same way, the Board of Directors (BOD) exists to protect



MAGDRL and enable us to operate with impunity. We procure insurance coverage for volunteers; we develop guidelines, policies and procedures to enable our safe and continuous operations; we require expense forms, and have income reporting and reimbursement procedures for

fiscal surety; and we closely track state, local, and federal legislation that may impact Chapter operations.

Our Coordinators and volunteers are the "Boots on the Ground" working for the success of their Chapter, but the BOD serves to protect the entire organization. Although few of us enjoy administrative overhead -- rules, procedures, forms & reports -they exist to avoid exposing MAGDRL to the types of risks that resulted in the closure of many nonprofits in recent years.

MAGDRL has kept our doors open for over 33 years thanks to the partnership between the Chapters and the BOD. We look forward to continued success in meeting our commitments to our donors, our volunteers, and most of all, to the Danes in our care.

Not every event turns out to be a big money maker, but we are getting out there, spreading the word about our awesome Danes which helps them find their forever homes!!! That is why we do what we do, and every effort is very much appreciated.

We have quite a few programs in place that keep a steady income coming into our treasury. The iGive, Purina Weight Circles, various recycle programs and our Dane Depot also continue to benefit MAGDRL. Other ongoing fundraisers include:

Legislative

Many areas in our Mid-Atlantic territories are making substantial

moves to protect animals and strengthen or create laws, although some have room for improvement. The majority of all US households now include at least one companion animal, and the public deeply cares about their pets and their welfare. People are also aetting more involved in contacting legislators and pushing for stricter laws. West Virginia,



Virginia and DC are included in the top tier for their strength in animal protection laws.

In 2011, there were many improvements in animal legislation taraeted towards better standards of care for animals. These include stiffer penalties for offenders, mental health evaluations for offenders, bans on ownership of animals following convictions, allowing animals to be included on domestic violence protective orders, reporting of cruelty by veterinarians and other professionals and expanding the range of protection for animals. Both Maryland and DC have new laws which allow animals to be included in domestic violence protective orders. North Carolina was also busy trying to push for stricter laws on puppy mills. Overall, it has been a decent year for companion animals but there is always room for improvement. Brittany Dail



One of my roles on the Board of Directors is that of MAGDRL Bite Coordinator. Along with MAGDRL President MaryFran, I receive bite incident reports.

This year I did some statistical analysis on bites that show the source of the bites (adopted/foster dog), what was bitten (dog/ human); in what state the bite occurred; and where the Dane originated. The graphs reflect the data from 36 incident reports over the course of a year.



The goal for 2012 is to reduce the overall number of incidents. We work towards this goal within each Chapter by doing more complete intake evaluations and also hope to see fewer repeat incidents by the same Dane.



New Jersey

NJ volunteers continued to work hard for MAGDRL in 2011, and once

again they outdid themselves with fundraising and events. NJ's income of over \$80,000.00 was more than 5 times its expenses, a trend that has continued in our Chapter for many years. We were proud to be able to help the entire organization with expenses, taking in fosters from other Chapters without available foster homes, and sharing the positive energy that our volunteers continue to generate. Our Tricky Tray fundraiser continues to be the highest earning fundraiser, and many vol-

unteers contribute in either small or big ways to make it so successful.

In 2011 NJ took in 33 Danes and 34 NJ families adopted Danes from MAGDRL.

The New York Chapter has another rescue year behind us where we saw many Danes being surrendered in very bad shape due to the economic crises, home loss, divorce. We also saw more Danes with major behavioral issues. Out of 100 calls, we could only take in 18 Danes this past year. Thanks go to our neighboring Chapters for opening their foster homes to accommodate NY Danes. It is great to work together as a team in these harder times.

We had some wonderful events where our volunteers had a great time educating and showing off the Danes to the public. We had attended many of these events in prior years and we were invited back again this year. North Carolina/Upstate South Carolina

We had another good -- but busy -- year in 2011 in the North Carolina/

We developed a recycling program we call "Going Green for the Danes." Brittany Dail set up an Etsy website so that we could sell recycled items for the rescue. New items we added to the program this year including water bottle toys, horse shoe reefs, recycled can broaches and tobacco stick stars. Our volunteers are always thinking of new ways to recycle items to sell at events, and all of our booth items are made and donated by MAG-**DRL** volunteers.

The NC/SC team had a total of 12 festivals: The Stampede, Watermelon, Pickle, Barbeque, Mum, Lawn Chair under the Oaks, Collard, Fossil, Potato, Strawberry, Turkey and Azalea. We also had 4 big events: Holiday Fair, Great Grapes, Bear Bourbon and Barbeaue, and Fur Ball. We also squeezed in some Bark in the Park events, Meet & Greets, and a couple of school visits to educate kids about Great Danes and rescue.

Thank you to all the Foster Homes and volunteers that were out every weekend educating the public.

West Virginia

In 2011, the West Virginia Chapter focused on continuing to strengthen

our volunteer base. We were able to fill five key positions, and our Panhandle group developed into a terrific team who really enjoy working together. We also focused on fundraising smarter. We were able to find venues where we could generate more dongtions per event, while also increasing our qualified adoption inquiries. We were also successful in reducing our costs for larger events to nearly nothing.



These efforts allowed us to handle inquiries, both surrender and support inquiries, from 92 Dane owners, while keeping up with the 266 total calls/emails received. We brought in 11 dogs, with two more pending the completion of an investigation. We celebrated 10 adoptions half of them in-state. We had only 2 surrenders that we had to refer to other rescues because they were in a part of WV that we could not reach. Thank you, everyone, for all you are doing for our orphans!

Dennsylvania/Delaware

In 2011, the Pennsylvania/Delaware Chapter had an unsettled year in terms of changes in Chapter leadership and volunteer roles. PA/DE Coordinator Sheila Marshall stepped down and Rachael Perring took



over her position. Rachel learned the ropes and continues in Sheila's footsteps. We handled 271 calls on our surrender line and took in 55 dogs. We experienced an increased number of "difficult dog" calls, with 94 of our calls being dogs that we were unable to accept due to MAGDRL policy. Fortunately we have a arowing relationship with outside rescues and resources and worked with them to resolve issues with these dogs. Unfortu-

nately 4 Danes died while in our care, but the great news is that we found 35 in-state and 11 out-of-state homes for PA/DE orphans.

We rallied together to make sure that the Danes came first at all times. By the end of 2011 we were stronger as a team and we hope to continue to arow together.

Maryland/DC

In 2011, the Maryland/DC give-up team fielded an average of 11 calls and



emails each month, which resulted in intake and placement of 35 Danes in new homes. Unfortunately that's an increase in dogs taken in, but a slight decrease in adoptions over the previous year. We also had 41 Danes adopted into homes within our Chapter. We saw more and more families affected by financial challenges which forced them to give up their Danes.

Our volunteers continue to be the heart and soul of the Chapter. If it were not for them, give-up and adoption calls would not be returned, home visits and dog evaluations would not happen. Meet & Greets would not occur, fundraising would be non-existent, and we would have no foster homes to place dogs in. It takes an army to keep this organization up and running, and that army is our MAGDRL volunteers. Every minute spent volunteering is appreciated, every penny collected is appreciate, I'm happy to be a part of such a dedicated and caring team. Christina Kallay

Southern Virginia

The Southern Virginia Chapter ended the year with 10 Danes still in rescue. We took in 33 Danes, down from the previous year by 7. We continue to grow and develop our volunteer base, striving for a well-rounded Chapter. Our Chapter will continue to focus on incoming Danes, successful adoptions/matchmaking and increasing our donations. We are also focused on managing our expenses, and educating the public. We also strive to continue building and assisting other Chapters to best utilize our resources.
